Please describe your experience in serving on a Commission or Board.

The past year (24-25) I served on the sub-committee of housing on the Senior Commission. PRNS secretary/staff assisted the Ad- Hoc housing sub-committee in its formation and agenda. The delegation of locating various low-income housing/units in the "affordable" range, attending non-profit organizations which specialize in housing policy, speaking with city council reps/staff on access to information all open the discussion on housing issues can best describe my experience.

Considering your experience and activities in business, labor, School, professional, social, Commissions, Boards, or other organizations, indicate the experience, training, knowledge and/or skills which qualify you for appointment.

While attending the various zoom/in-person city meetings (City Council) I would listen to the agenda items and voice my opinion during public comment. My belief is that my opinion matters no matter the decisions made by the organizations. Public speaking is a skill I learned in school and during Toastmaster sessions. As a Sub-teacher, I regularly direct children/teens in a classroom setting per teacher instructions. I attend Important social meetings (Silicon Valley @Home) which can/do pertain to tour AD-HOC Housing. I have also received an Entrepreneur certificate from Del Mar adult ed in 2021 to better my business acumen. As a senior who recognizes my life skills qualify as a component to serving on commissions, I bring a wealth of knowledge and experience.

What is your understanding of the purpose of the Commission?

Participation as an older American, it is my obligation to stay informed about issues, meetings, agendas and input from commissioners. Interacting with staff in setting an agenda for the purpose of bringing those issues to the city council is important. The impact of the meetings sets up a quorum where votes determine whether topics can be expanded upon, such as nutrition in the form of meals served at community centers, which speakers can present and discussion on policy issues affecting seniors.

Please list three issues facing the City that you feel the Council should address.

Housing, safety and techie (computer,etc.) issues are critical issues for Seniors. The San Jose City Council has a representative(Pam Foley/Vice Mayor) and staff who does/will address the commission and city council. When the city council meets, budget decisions can alter the direction of the Senior Commission. Policy makers within city government also interject with decisions affecting seniors. Planning commission, housing commission and human services are examples.

What is the purpose of historic preservation in San José and what is the role of the Historic Landmarks Commission in achieving that purpose?

The purpose of preservation is to conserve/protect the architecture of a particular historic district. That includes new development that should conform with those standards. The Landmark Commission must maintain a list of historic structures in San Jose. The Historic Preservation Ordinance includes HP permits to be reviewed by the commission and involve public comment on reconstruction of older buildings. The Alum Rock corridor is an example of o maintaining historic and cultural relevance while developing the area.

Please explain your prior experience with historic preservation, with San José's public planning processes, and in working with City or other public agency staff.

I have attended (via Zoom) the commission on Landmarks via the public forum. While protecting historic buildings, I have maintained that preserving the environmental surroundings,(setting/landscape) such as magnificent ordinance/non-ordinance trees to be just as important. (On record) During the planing process (per Mr. Burton- Director of PBCode) staff recommendation (memorandum) per development projects, (CEQA, EIR), outweighs the impact to historic districts and comments on City Council considerations to those projects. Public input/comments are also welcomed during the review process which might impact an historic neighborhood.

What is a major issue facing San José's older adults and what do you see as the Commission's role in this issue?

Housing issues are a priority for older adults and the role of a Commissioner is to be a proponent for those who are struggling in this domain. The city council and Housing Commission of San Jose work with the County on issues of veteran homeless struggles and unhoused seniors. While the Senior Commission continues to tackle the un-housed population of older adults, it is an area the Commission must face with additional resources and input. The /ad-hoc committee began last year (2024) should be top priority.

i have been to many of the Senior meetings which are run by PRNS, who then directs the comment/question period on various agenda items the commission discusses. When there is a difference of opinion the commissioners speak on them when called upon. Discussion takes place and a vote is taken. A quorum needs to be in place for the votes to be counted and recorded. Positions must be heard at the Commission meetings and the individual commissioner is allowed to comment.

I myself am a senior citizen who currently resides in senior housing. The Senior Commission had a housing sub-committee presided over by past president- Gina-Gates Lopez-on which I served. The issues pertinent to us were affordable housing/ units available/ and interactions with various non-profits/governmental agencies. Seniors don't always understand how to navigate the housing catalogue/qualifications when searching for living accommodations. Safety in our communities is another key issue that the Sr. Commission addressed as well as avoiding monetary Scams. I have experienced all of these first hand and have learned some valuable life lessons, of which Seniors should be made aware. I have attended many zoom board/commission meetings, such as Housing/PRNs/Youth Commission/Climate Advisory, Board of Supervisors, and others. It is important to be informed about all subjects affecting our neighbors.

Anything else you would like us to know?

As a technical issue, I often resort to the library for assistance with my lap-top (computer). Seniors constantly need updates and supports with technology, which includes viruses and security threats. Being independent, seniors are a great benefit to the community via life experience, however ,liife-long learning involves updating our skills while navigating the digital/ virtual world. I'm proof that it is possible.
