**SUBJECT: Public Hearing on San José Municipal Water System Potable  
(Drinking) and Recycled Water Rates and Charges**

## **RECOMMENDATION**

- (a) Hold a public hearing on San José Municipal Water System potable and recycled water rates and charges effective July 1, 2026.
- (b) Adopt a resolution to increase the current San José Municipal Water System potable water rates and charges effective July 1, 2026.
- (c) Adopt a resolution to increase the current San José Municipal Water System recycled water rates and charges effective July 1, 2026.

## **SUMMARY AND OUTCOME**

Approval of these recommendations will allow the San José Municipal Water System (SJMWS) to update potable and recycled retail water rates effective July 1, 2026, and generate sufficient revenue to fund projected utility operating costs as reflected in the Fiscal Year (FY) 2026-2027 Proposed Operating Budget that will be slightly amended as discussed later in this memorandum.

## **BACKGROUND**

SJMWS is a rate-funded utility that is intended to operate at full cost recovery to provide water to approximately 27,000 customer accounts, serving a population of over 140,000 people in the North San José, Alviso, Evergreen, Edenvale, and Coyote Valley areas. SJMWS purchases potable water for the North San José and Alviso areas from the San Francisco Public Utilities Commission (SFPUC), which delivers treated water through its Hetch Hetchy Aqueduct from the Sierra Nevada Mountain range. Potable water for the Evergreen and Edenvale areas is purchased from the Santa Clara Valley Water District (Valley Water) and comes from the Sacramento-San Joaquin River Delta, delivered through the State Water Project and Federal San Felipe Project, and local groundwater sources. SJMWS supplies all potable water for the Coyote area from local groundwater sources. Recycled water is purchased from South Bay Water Recycling and is retailed to customers in all service areas.

In 2016, the City contracted with Raftelis Financial Consultants (RFC) to conduct a cost-of-service analysis for the potable water enterprise of SJMWS. The purpose of the analysis was to evaluate the utility's potable system revenue requirements through the development of a Financial Plan and an up-to-date Cost of Service evaluation. RFC presented the result of its analysis at the City Council's May 9, 2017 meeting.

In addition to potable water, SJMWS retails recycled water. The revenue requirements of retailing recycled water are collected from recycled water rates. To ensure that the City accurately establishes rates to match revenue requirements, the City contracted with HF&H Consultant, LLC (HF&H) in 2018 to conduct a cost-of-service analysis.

Proposed rates are based on the analysis performed as part of the RFC and HF&H's studies. Adoption of the resolutions and approval of the ordinance will implement the rate changes for the potable (drinking) and recycled water rates, effective July 1, 2026.

## **ANALYSIS**

### **Potable Water Rates and Charges**

The two principal sources of revenue for SJMWS are water sales and fixed monthly meter service charges. Approximately 65% of SJMWS' potable water revenue is used to purchase water from wholesalers and pay the Valley Water groundwater augmentation fee for groundwater pumped by SJMWS. The total cost to operate, maintain, and rehabilitate the water utility system (excluding any reserves) has a budget of \$81.0 million in FY 2025-2026 and \$81.9 million in FY 2026-2027, as shown in the FY 2026-2027 Proposed Operating Budget that will be slightly amended as discussed later in this memorandum.

Changes to water rates are primarily related to the increased cost of wholesale water that SJMWS purchases from the SFPUC and Valley Water. Additionally, \$8.8 million is transferred annually to the Water Utility Capital Fund for planned infrastructure improvements. Nominal cost changes related to energy, offsetting delinquent and uncollected revenue, and increased operating, maintenance, and overhead expenses may additionally result in a base adjustment to meter and quantity charges.

In early 2026, the SFPUC informed wholesale customers of a potential 9.1% maximum rate increase for FY 2026-2027 and Valley Water notified property owners that wholesale rates for North County groundwater may increase by up to 9.1% for FY 2026-2027. These maximum potential rate increases were used in compiling the Source and Use of Funds Statement for the Water Utility Fund in the FY 2026-2027 Proposed Operating Budget.

It should be noted that Valley Water has identified that wholesale water rates are expected to continue increasing over the next 10 years, including 7-9% annual increases through FY 2035-2036. Furthermore, wholesale rate increases may be higher in the future if drought conditions return, wholesaler costs continue to escalate, and/or water use during FY 2026-2027 is lower than wholesalers' estimates. Due to the projected rapid rise in wholesale water rates over the next several years, delaying rate increases or using reserves to offset FY 2026-2027 retail water rates would likely negatively impact the health of the Water Utility Fund and lead to significantly higher SJMWS rate increases in subsequent years.

As SJMWS estimates that the total volume of water sold during FY 2026-2027 will be similar to FY 2025-2026, in developing the Proposed Budget, staff assumed a budgeted revenue increase of up to 8% would be necessary to ensure the continued operation of the water utility system, including the purchase of wholesale water. This revenue adjustment was distributed amongst all customers in developing proposed rates, with rate changes per customer varying based on service area and associated wholesale water supplier. In April 2026, notices were sent to inform all SJMWS water customers that City Council would be holding a public hearing to consider potential changes in retail water rates and charges effective July 1, 2026. The notice contained the new maximum meter charges and water quantity rates per zone, assuming a 9.1% increase in the cost of wholesale water and a 2% base increase in meter and quantity charges. The proposed overall rate change varied by customer based on service area, pressure zone, and water usage. Based on proposed rates in the initial notice, a representative sample increase on an average residential bill based on water usage of 13 hundred cubic feet with a 3/4-inch water meter in the North San José/Alviso service area would be an additional approximate \$10 (or 6.5%) per month, while the same representative sample residential bill would see an approximate \$10 (or 6.6%) per month increase in the Evergreen/Edenvale-Zone 1 area.

Final proposed rates are lower than those included in the notice sent to customers. After notices were sent, on April 28, 2026, the SFPUC adopted a 7.4% increase in wholesale water rates - lower than their previously projected 9.1% increase. The Valley Water

Board adopted a 9.1% increase in wholesale water rates on May 12, 2026. The SJMWS operations and maintenance budget will be revised to reduce Citywide costs, resulting in no base change to meter and quantity charges. After these adjustments, the final proposed rates will decrease for all customers as compared to the rate notice sent in April. See Attachment A - Proposed Rate Schedule. A representative average residential water bill will increase in the North San José/Alviso service area by approximately \$6 per month and by \$7 per month in the Evergreen/Edenvale-Zone 1 area.

#### Financial Assistance and Water Savings Tips

SJMWS has implemented programs to assist with water bill affordability. During early 2022, the City received funding from the California Water and Wastewater Arrearages Payment Program (Arrearages Program) to assist customers with delinquent water bills. Over 1,000 customers received approximately \$541,000 in Arrearages Program funding and an additional \$356,000 waived in late payment charges. Staff applied to the state and received additional funding in an Extended Arrearages Program during FY 2023-2024. During April and May 2024, the City distributed an additional \$976,000 in Extended Arrearages Program funding to approximately 1,300 customers, with an additional \$569,000 waived in late payment charges.

Local implementation of the state's Low-Income Household Water Assistance Program, operated by Sacred Heart Community Service, began in summer 2022 and ran through March 2023. Under this program, eligible residents could receive up to \$15,000 to pay their water bills. While the state's program has ended, Sacred Heart Community Service continues to offer a program to assist low-income Santa Clara County residents with their water bills.

The City implemented a Utility Billing Amnesty Program from April 1, 2025 through September 30, 2025, which provided financial relief to eligible water and garbage utility customers who had delinquent balances on their City of San José utility accounts. Under this program, customers that paid the outstanding principal balance on their utility account could have their late penalty balance waived. Approximately 2,100 water customers benefitted from this program, which resulted in the waiver of \$1.2 million in late payment charges and the collection of over \$1 million in delinquent water service charges.

On May 12, 2026, City Council approved the implementation of a one-year pilot program aiming to provide additional financial support to low-income or vulnerable customers whose water service has been disconnected due to nonpayment. The pilot will be managed and tracked to allow for evaluation of program effectiveness and the cost to implement and may include a one-time credit of up to \$500 per year to support eligible low-income or vulnerable customer accounts in the collection process.

Staff will continue to monitor for any additional customer assistance programs which could be implemented and will coordinate as necessary to ensure SJMWS customers are informed of and can participate and receive additional financial support where eligible. Despite the financial hardship some customers may be experiencing, water service continues to be an affordable public commodity. Including the proposed rate increase, customers pay approximately \$0.01 per gallon for clean drinking water.

Water conservation continues to be the best practice for reducing the impact of higher water rates and saving money. In addition to ongoing outreach and messaging, the City's website ([SJEnvironment.org/WaterEfficiency](https://SJEnvironment.org/WaterEfficiency)) provides information to customers on water saving tips, along with updates to water use rules for customers and businesses. SJMWS staff are available to assist customer inquiries and provide further resources.

### Other Potable Water Agency Charges

Other retail water agencies within the Bay Area have proposed water rate increases for FY 2026-2027 or may increase water rates to recover wholesale rate increases and other inflationary costs. Table 1 shows estimated monthly bill figures for general comparison and consideration purposes and are representative of sample residential monthly bills based on water usage of 13 hundred cubic feet (9,725 gallons) with a 3/4-inch water meter. This information is tentative and based on best available information and is subject to change based on the actions of each agency's governing board.

## **Recycled Water Rates and Charges**

In 2018, HF&H examined the cost of service to retail recycled water, resulting in a slight change to the recycled water rate structure. Based on HF&H's analysis, retail recycled water rates were adjusted to a structure which provides increased revenue stability in recovering delivery fixed costs. Recycled water service charge rates were set equal to the potable water service charge rates. A uniform quantity charge rate was set for all retail recycled water customers.

HF&H recommended setting future recycled water service charges rates equal to potable water service charge rates and to increase the uniform quantity charge rate proportional to the increase in wholesale water costs. Pursuant to City Council Resolution 79111 (continuing in effect Resolution 68377), recycled water quantity charges will continue to be automatically increased every year in proportion to any increase in wholesale recycled water costs.

As shown in Table 2, SJMWS's recycled water customers will continue to realize significant savings over potable water even with the increase to retail recycled water rates. Rate details for recycled water are provided in Attachment A.

## **EVALUATION AND FOLLOW-UP**

Staff will return annually to the City Council with any recommended changes for the following year's rates. A supplemental memorandum will be submitted to the City Council prior to the June 2, 2026 public hearing to report on the number of written protests and comments received by the City Clerk's Office in response to SJMWS' rate notice. Furthermore, there is a 120-day statute of limitations to challenge any new, increased, or extended fee or charge.

## **FISCAL IMPACTS**

The FY 2026-2027 Proposed Operating Budget assumes an overall 8% water retail sales revenue increase from the FY 2025-2026 budget in the Water Utility Fund, generating approximately \$85.5 million in revenue in FY 2026-2027 to recover the full cost of operating and maintaining the SJMWS distribution system that includes increased wholesale water costs and capital infrastructure needs. As previously discussed, due to the lower wholesale water rate increase approved by SFPUC and no increases being realized in meter charges, SJMWS program revenue will increase by 5%, rather than the initially projected 8%. The budget changes to revenue and corresponding decreases in water purchase expenditures will be reflected in the forthcoming MBA, Recommended Amendments to the 2026-2027 Proposed Operating and Capital Budgets.

It is important to note that the overall 5% increase in revenues is not necessarily representative of a customer's water charges or representative of a monthly increase, as rates vary customer to customer, primarily determined by water supply source, elevation/zone, and usage. For a full schedule of proposed rates, please see Attachment A.

If City Council approves the resolutions changing SJMWS potable and recycled water rates and charges, as recommended in this memorandum, revenue will be generated of approximately \$82.9 million to support increased utility operating and capital costs and to ensure sufficient revenues to offset the write-off of a portion of unpaid bills.

## **COORDINATION**

This memorandum was coordinated with the City Attorney's Office, City Clerk's Office, and City Manager's Budget Office.

## **PUBLIC OUTREACH**

In April 2026, public notices were sent directly to all water customers advising them of the proposed rate changes, that a public hearing on the proposed rate change is scheduled for June 2, 2026, and that there is a 120-day statute of limitations to challenge any new, increased, or extended fee or charge. Notices and frequently asked questions were made available to customers in six languages (English, Spanish, Korean, Vietnamese, Chinese, and Tagalog) on the Environmental Services Department's Proposed Rate Change webpage at [SanJoseCA.gov/RateNotices](https://SanJoseCA.gov/RateNotices). In advance of City Council consideration of the proposed rate increases, SJMWS mailed a 'Where Your Dollar Goes' conservation postcard to residential customers on March 10, 2026, and published a notice in the Mercury News on May 12, 2026.

As of May 11, 2026, the City Clerk's Office had received 157 letters of protest to potable water rates from SJMWS customers and no protests to recycled water rates, in response to the public notices. Written protests have been received by mail, fax, and email. In compliance with California Assembly Bill 2257, 'Local government: property-related water and sewer fees and assessments: remedies' (passed September 2024), the City issued responses to SJMWS customers submitting protests to proposed increases (Attachment B – Response to Municipal Water Protests Received)

This memorandum will be posted on the City's Council Agenda website for the June 2, 2026 City Council meeting.

Dear San José Property Owner/Customer:

This message is to acknowledge receipt of your written protest to the City of San José's proposed Potable/Drinking Water utility rate increase proposal. We understand that this proposed increase is an additional cost to you. Here is some additional information about the need for it.
