AN ORDINANCE OF THE CITY OF SAN JOSE AMENDING CHAPTER 4.80 OF TITLE 4 OF THE SAN JOSE MUNICIPAL CODE TO ADD NEW PARTS RELATED TO THE ESTABLISHMENT OF THE VRF MEASURE B PAVEMENT MAINTENANCE FUND; THE INTERSTATE 280/WINCHESTER TRAFFIC IMPACT FEE FUND; THE NORTH SAN JOSE TRAFFIC IMPACT FEE FUND; THE NORTH SAN JOSE TRAFFIC IMPACT FEE FUND; THE EVERGREEN-EAST HILLS TRAFFIC IMPACT FEE FUND; THE STATE GAS TAX PAVEMENT MAINTENANCE FUND; AND THE VTA MEASURE B PAVEMENT MAINTENANCE FUND

WHEREAS, pursuant to the provisions and requirements of the California Environmental Quality Act of 1970, together with related State CEQA Guidelines and Title 21 of the San José Municipal Code (collectively, "CEQA"), the Director of Planning, Building and Code Enforcement has determined that the provisions of this Ordinance do not constitute a project, under File No. PP17-010 (City Organizational & Administrative Activities resulting in no changes to the physical environment) and File No. PP17-004 (Government funding mechanism or fiscal activity with no commitment to a specific project which may result in a potentially significant physical impact on the environment); and

WHEREAS, the City Council of the City of San José is the decision-making body for this Ordinance; and

WHEREAS, this Council has reviewed and considered the "not a project" determination under CEQA prior to taking any approval actions on this Ordinance;

VRF Measure B Pavement Maintenance Fund

There is hereby created and established the "VRF Measure B Pavement Maintenance Fund."

4.80.5220 Source of Monies

The source of monies budgeted and accounted for in the VRF Measure B Pavement Maintenance Fund shall be monies received from vehicle registration fees collected from the Santa Clara County Vehicle Registration Fee Measure B ballot measure approved by voters in November 2010.

4.80.5230 Expenditures

Monies in the VRF Measure B Pavement Maintenance Fund shall be expended for sealing and resurfacing of streets, repairing potholes, and administering the Department of Transportation's pavement programallowable transportation-related improvements as specified in the approved Santa Clara County Vehicle Registration Fee Measure B ballot measure and Santa Clara Valley Transportation Authority guidance interpreting Measure B, including, but not limited to, repair of potholes, repaving and maintaining local streets, improving traffic flow on local roads, improving safety, and paying for other congestion and pollution mitigation projects (examples of which include pavement

rehabilitation and reconstruction, traffic control signals, curb and gutter rehabilitation

and reconstruction, roadway related facilities to improve safety, and automobile related

generate future vehicle trips requiring transportation improvements.

measure, including, but not limited to, repairing and maintaining the street system,

improving bicycle and pedestrian elements of the street system, and congestion relief

projects.

Interest which accrues from monies in the VTA Measure B Pavement Maintenance

Fund shall be credited to this Fund.

SECTION 8. The provisions of this Ordinance shall take effect retroactive to July 1,

2025.
