I value inclusive planning, equitable access to public spaces, and thoughtful community design. I've completed a Stanford course on conflict resolution where we practiced difficult conversations, learned how to actively listen and paraphrase concerns, and studied how to avoid insincere or dismissive language when tensions are high. These skills have served me well professionally; for example, when resolving team conflict by showing support for a partner team's deadlines, or mediating disputes between managers competing for interns by refocusing on what best served the interns' experience. I'm also committed to ethical conduct, civic responsibility, and impartial service. I see public boards and commissions as critical to maintaining transparency, fairness, and trust in our institutions. Three critical issues facing the City that I believe the Council should prioritize are: 1. This includes exploring innovative zoning solutions, increasing the supply of affordable housing units, and investing in comprehensive support services for individuals experiencing homelessness. 2. Transportation and Infrastructure: With continued growth, San Jose faces increasing strain on its transportation systems and aging infrastructure. San Jose, as a major city, can influence the rest of the country through the implementation and enforcement of common-sense rules, regulations. I am an avid reader of books on history, economics, fiscal and electoral policy. Of particular interest in this case is "Making Democracy Count" by Volič.

I see the Commission as currently having responsibility for the monitoring and enforcement of campaign law, particularly around campaign finance and ethics. I am hoping to learn more about the Board and the nuances of San Jose elections through involvement in the Board, and to understand how I can apply my knowledge to influence the continuous improvement of democracy (small "d") in the city.

Please list three issues facing the City that you feel the Council should address.

1. Democracy, tempered by the protection of basic rights, is the absolute foundation of a just society. As stated above, I see a flaw in the plurality election mechanism, which leads to people being compelled to vote contrary to their preferences to ensure their vote matters, and that leads to a winner that does not have the support of the majority of the electorate. The simple resolution of this is instant-runoff, rank-choice voting. This would also save the City the expense of runoff elections under circumstances that have arisen even recently. 2. The reality of elections in the City (not to mention State and Federal) elections is that it requires a candidate to have a large number of wealthy friends and acquaintances to enable them to afford the considerable expenses of a campaign. This is admittedly not a simple problem to solve! Public funding of elections is one mechanism, but this requires that the City has the funds, and it would also require a stringent system to enable someone to qualify for those funds (probably that the candidate acquire a large number of qualified signatures on a petition for them). But it is definitely something to consider to promote true democracy. 3. Then there are issues not related to the Board (and I know I am cheating): homelessness, budget, city planning to reduce traffic congestion and increase economic prosperity, and climate preparedness (SJ is a low-lying city that is threatened by climate change).
