### **RECOMMENDATION**

Adopt "Tsugio Fujimoto Park" as the official name for the park located along Senter Road between Serenade Way and Diamond Heights Drive, as recommended by staff and the Parks and Recreation Commission and as a result of the public outreach process.

### **SUMMARY AND OUTCOME**

Approval of the recommendation will officially name a new park located at Senter Road and Serenade Way and with City Council approval the park site will also be designated as chartered parkland.<sup>1</sup>

### **BACKGROUND**

The new 0.36-acre pocket park is located along Senter Road between Serenade Way and Diamond Height Drive.<sup>2</sup> The park is situated on a triangular piece of City of San José (City)-owned land previously occupied by an underutilized traffic island and is bounded by housing on all three sides. The site is on the southern edge of the South San José Planning Area in Council District 2 (Attachment A – Location Map). A former

Cold War era Civil Defense siren is located on the site.<sup>3</sup> The park provides walking, fitness opportunities, and a gathering space for the local community. Improvements include a native pollinator garden and new shade trees.

The park site was developed outside of the City's conventional master planning process. The concept of a park site started in 2021 through efforts lead by the Council District 2 Office (Council Office). In the spring of 2023, the Council Office conducted initial community outreach via a survey that led to the planning of the park site.

The Mayor's June Budget Message for Fiscal Year 2023-2024 directed the City Manager to allocate \$250,000 in one-time funding from the District's "C&C Fund towards the undeveloped island on Senter Road near Serenade Way to transform the often blighted space into a beautiful location that neighbors can appreciate.<sup>4</sup> The 2023-2024 Adopted Budget provided funding to convert the 0.36-acre parcel into a future park to increase recreational opportunities for the surrounding community.<sup>5</sup>

The community participated in the park planning process via a community survey initiated by the Council Office and a community meeting. On January 17, 2024, staff presented park concepts for feedback. In summary, the community voiced an interest in active and passive recreational amenities. The proposed amenities included exercise equipment, curved walking paths, game tables, benches, native plants/trees, and a pollinator garden. Instead of benches, another type of seating was provided at game tables. The park design is consistent with the community input. The park opened in December 2024. A park sign will be installed in summer or fall of 2026.

In addition, staff advanced a park naming process. Community members who participated in online public surveys expressed a preference (39%) to name this park "Fujimoto Park" to commemorate Tsugio 'Tee' Fujimoto and reflect on his years of service to the City of San José as a supervisor and park gardener (Attachment B – Online Public Survey Results). Staff recommends adopting the full name, "Tsugio Fujimoto Park" to more accurately honor the individual, Tsugio Fujimoto.

On October 1, 2025, the Parks and Recreation Commission recommended naming the park site, "Fujimoto Park" based on staff's recommendation, public outreach and public feedback.<sup>6</sup>

### **ANALYSIS**

City Council Policy 7-5, Naming of City-Owned Land and Facilities, (Policy 7-5) establishes guidelines and procedures regarding naming City-owned land and facilities that are not public streets. Per Policy 7-5, the official names must reflect at least one of the following criteria:

- Geographic location;
- Prominent geographic feature or local reference point;
- Adjoining subdivision/community;
- Historical event;
- An individual who has made significant contributions to San José, the state, the Nation, or the World and who has been deceased for at least five years;
- An individual via a donation or sponsorship agreement; or
- A group via a donation or sponsorship agreement.

Additionally, Policy 7-5 encourages names that reflect the City's ethnic and cultural diversity. Staff will recommend names that reflect the intention of Policy 7-5 as well as names that align with the City's Racial Equity commitment.<sup>7</sup>

Staff finds that naming the park "Tsugio Fujimoto Park" aligns with the City's naming policy, most community participants, and the City's objective for an inclusive and equitable park system.




Figure 1: Image of Tsugio 'Tee' Fujimoto

The name, "Tsugio Fujimoto Park" reflects a deceased individual who made significant contributions to San José. Tsugio 'Tee' Fujimoto was an active member of the San José Landscape Gardeners Association and served as a landscape maintenance supervisor for the Parks, Recreation, and Neighborhood Services Department (the Department) from the late 1950's until his retirement in 1982 (See Figure 1 for an image of Tsugio 'Tee' Fujimoto). Tsugio 'Tee' Fujimoto was commonly known as 'Tee' among his coworkers within the Department. Four retired gardeners suggested this park name to honor Tee's high regard among his peers and "as a memory and tribute to his important

work for the City of San José Parks Department" and for "his important role influencing a viable department as it expanded" (Attachment C – Analysis of Name Suggestions Received). His extensive knowledge of plants helped to guide the expansion and refining of parks development from 1957 to 1982. Tsugio 'Tee' Fujimoto supervised staff at the Municipal Rose Garden, the Japanese Friendship Garden, Kelley Park, City Hall, the Performing Arts Center, the Convention Center, and Happy Hollow Park & Zoo, as well as other locations. Those that worked with Tsugio 'Tee' Fujimoto describe him as very knowledgeable in his field of expertise, well-respected, and dedicated. Tsugio 'Tee' Fujimoto lived less than a block away from the Senter and Serenade park site.

### **Policy Alternatives**

Alternative #1: The City Council could select an alternative park name from the list of eligible names generated through the public outreach process.

**Pros:** The City Council could adopt a different name from the list of qualifying names received through the public outreach process. Fujimoto Park, Serenade Park, and Clara Shortridge Foltz Park were the highest-ranked names in the public survey and would honor a local reference point and deceased individuals.

**Cons:** The City Council would be selecting a name other than the one recommended by the Parks and Recreation Commission and the results of the community surveys.

**Reason for not recommending:** Members of the Fujimoto family support the name "Tsugio Fujimoto Park." It is consistent with public input and the Parks and Recreation Commission's recommendation.

Alternative #2: The City Council could suggest one or more new names per Council Policy.

**Pros:** The City Council would be selecting a new name other than the one recommended by the Parks and Recreation Commission and the results of the community surveys.

**Cons:** The City Council would be selecting a name other than the one recommended by the Parks and Recreation Commission and the results of the community surveys. Additionally, the City Council would be selecting a name not previously considered by the community and the new name might not comply with Policy 7-5, which may result in delaying the naming.

**Reason for not recommending:** Members of the Fujimoto family support the name "Tsugio Fujimoto Park." It is consistent with public input and the Parks and Recreation Commission's recommendation.

# **Racial Equity Impact Analysis**

The name, "Fujimoto Park," represents a Japanese American internment camp survivor and veteran. 10 Tsugio was among approximately 33,000 Japanese Americans who

voluntarily served during World War II despite being confined in internment camps.<sup>11</sup> Tsugio 'Tee' Fujimoto was a World War II internment camp survivor who deeply valued the City job he received after returning from internment.<sup>12</sup> This history enriches the park's name, showing how naming public spaces can honor untold stories, address past injustices, and build community identity.

### **EVALUATION AND FOLLOW-UP**

Once a name is adopted, staff will coordinate with the City Clerk's Office to ensure the name is recorded and the Public Works Department to include the name on all park signage.

### **COORDINATION**

The memorandum has been coordinated with the City Attorney's Office and City Manager's Budget Office.

### **PUBLIC OUTREACH**

This memorandum will be posted on the City's Council Agenda website for the December 9, 2025 City Council meeting.

The Department completed a multi-phase public participation process that consisted of two community meetings and two online surveys. The process allowed the community to engage in the development of the conceptual park designs and name options for the park site.

In May 2023, the Council Office circulated a survey to engage residents and gain an understanding of the community's priority for the use of the space (Attachment D – Survey Circulated by Council District 2 in May 2023). On January 17, 2024, the Council Office hosted a community meeting at Christopher Elementary School. Approximately 20 community members attended the meeting.

Of the approximately 120,000 Japanese Americans forcibly confined into internment camps, more than 33,000 Japanese American citizens voluntarily served in the military during World War II while their families remained confined in internment camps. This would be the second park honoring a Japanese American internment camp survivor, following City Council's April 29, 2025, adoption of the name "Eiichi Edward Sakauye Park." Additionally, two City facilities already recognize the City's Japanese American heritage: the Japanese Friendship Garden in Kelley Park and the Shirakawa Community Center, named for Councilmember George Shirakawa Senior.

During the community meeting, staff presented themed concepts. Members of the community voiced an interest in exercise equipment, curved pathways, game tables, benches, a pollinator garden, and California native plants and trees. The community input informed the final park design. The park was officially opened to the public on December 9, 2024.

Staff used the December 9, 2024, ribbon cutting ceremony as an opportunity to kick off the park naming community engagement process. Public engagement consisted of two online community surveys and an in-person community meeting.

The first online public survey (December 7 to December 23, 2024) opened immediately prior to the December 9, 2024, ribbon cutting ceremony. Survey participants were provided a list of name suggestions and given the opportunity to suggest additional name suggestions. Staff received 129 responses to the survey (Attachment B). In addition to the name suggestions provided by staff, the first online survey resulted in 21 name suggestions with five qualifying names that aligned with Policy 7-5. Additionally, a name suggestion, was received via a letter resulting in the "Fujimoto Park" name suggestion, raising the total number of name suggestions to 22. Similar and redundant name suggestions were combined to allow the public to vote on a qualified list of name options (Attachment C).

On May 27, 2025, staff presented the park naming to the Melody-Serenade Neighborhood Association. A total of nine attendees attended the meeting, including members of the neighborhood association, the Council Office councilmember and staff, and a retired gardener who spoke on behalf of the "Fujimoto Park" name recommendation. The neighborhood association livestreamed the meeting. Staff provided an update on the park naming, reviewed the results of the first online survey, provided an overview of the naming process, reviewed the name options for the second public survey, and encouraged the public to complete the online survey.

The second online public survey (May 27 to June 11, 2025) opened immediately following the presentation to the neighborhood association. Participants ranked the name options in the order of their preference. Staff received 122 responses to the survey, which resulted in the following name preference order: 1) Fujimoto Park; 2) Serenade Park; and 3) Clara Shortridge Foltz Park. The response with the largest weighted score informed staff's recommendation for the park site.

The community was notified of the meeting and surveys via the following methods:

Targeted social media notification through the Department's Facebook,
 Nextdoor.com, Instagram, and Facebook accounts to residents within two miles

of the development site. In total, the social media blasts resulted in 5,238 impressions, 36 interactions, and a reach of 4,899 on Facebook; 413 impressions on Nextdoor.com; and a reach of 3,789 and 155 interactions on Instagram.

 Email notifications sent include the Melody-Serenade Neighborhood Association, Council District 2 staff, Seven Trees Branch Library, six schools within a 10minute walk of the park site, Project Hope staff, San José Parks Advocates, San José Parks Foundation, over 40 community organizations, and various individuals. In total, 15 email blasts resulted in over 1,156 email notifications sent to the constituents listed above.

The survey and outreach materials were made available in English, Spanish, and Vietnamese. The first survey received responses in English only. The second community survey received 122 responses in English and four responses in Spanish.

### **COMMISSION RECOMMENDATION AND INPUT**

The Parks and Recreation Commission considered the staff recommended name, "Fujimoto Park" during the October 1, 2025, meeting. <sup>14</sup> A member of the Fujimoto family and two retired gardeners spoke on behalf of the staff recommendation during the meeting. Additionally, two public comment letters supporting the name recommendation were read aloud. During the public comments, the family member shared that Tsugio 'Tee' Fujimoto was a World War II internment camp survivor who deeply valued his City job after losing everything during internment. <sup>15</sup> Tsugio 'Tee' Fujimoto was also a veteran who served in the armed forces during his forced internment.

Staff committed to reach out separately to the public commenters to capture the stories and make them available to the public.

Vice Chair Barocio motioned to approve the Park Naming for the Senter and Serenade item, which was seconded by Commissioner Morrow. The motion was carried (8-0-2, Snider and Garcia-Barnwell absent).

Figure 1: Site Location Map






Figure 2: Regional Location Map








Survey 2: Park Naming Ranking


# 1. Staff Suggested Potential Names (From Survey#1)

Serenade Park	References the adjacent street, Serenade Way, and also honors the musical theme of the adjacent neighborhood. The streets in the immediate neighborhood have musical themed names, such as Serenade Drive, Concerto Drive, Rhapsody Way, Symphony Lane, and Lullaby Lane.
Siren Park	References the prominent geographical feature on the site, the Cold War era <u>Civil Defense Siren</u> . Civil Defense Sirens and <u>fallout shelters</u> were installed throughout the 1950s and 1960s. The sirens were used throughout the <u>Cold War</u> to alert residents of a potential missile strike. These sirens were scattered throughout and were typically located in areas that were once near the City boundary.
Woodwind Pocket Park	Denotes a musical instrument, or woodwind, while playing off the idea of a "woodland." The park site has several trees on it.

Fujimoto Park. Many of us who worked for or knew Tsugio 'Tee' Fujimoto had respect for his knowledge and dedication to landscape maintenance. Mr Fujimoto resided two houses from the park on the south side of Senter Road.' Tee' embodied the idea that every park landscape should be well kept and attended to routinely by parks staff. He believed that if someone was not tired at the end of a work day they were not doing the job right. He encouraged hard work and learning plant maintenance on the job, through offered training, or by enrolling in junior college courses in the area. Tee was direct and emphatic to his new and older workers who followed his practices. If your parks were orderly and praised by others he would offer respect that helped his workers develop the right way. Though direct and contrite in his direction and tone he understood the nature of his workers and others.
