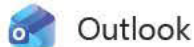

Hello Toni,

You spoke to our Roosevelt Park Neighborhood Association earlier this year. Your points about audits stuck with me. I think it's time for another audit of the city's DOT, specifically its Vehicle Abatement and Parking Compliance Departments.

If you read this email stream from the bottom up, it documents a single vehicle that exemplifies the futility that so many of us feel daily with abandoned or otherwise derelict vehicles on the streets in our neighborhoods. Especially in East San José.

I chose this particular vehicle because I reported it originally on July 24 (SJ311PSR20250724-0014), only to have Parking Compliance post it and allow it to be moved elsewhere. It moved 150 feet around the corner onto

Shortridge Ave from where it had been on S 28th St.

Fast forward to November 1 when I reported it again using SJ311 (SJ311PSR20251101-0017). The vehicle had not moved from its location on Shortridge Ave in the intervening 3 months. Parking Compliance again posted the vehicle and allowed it to be moved, this time one block west and one block south onto E San Fernando St near S 26th St.

Courtesy of my brother's research back into the 2013 *"Consulting Agreements: Better Enforcement of Procurement Rules, Monitoring, and Transparency is Needed"*, I believe that Vehicle Abatement and Parking Compliance have reverted to some of the questionable practices that lead to the audit's adverse findings in 2013. They are highlighted in the email stream below.

Now the question is: What does it take to trigger an audit? If I remember correctly, you collect recommendations and then create a work plan that is voted on by the City Council. Should multiple Councilmembers write a memo recommending an audit? I have copied the three whose districts encompass most of East San José on this.

Your thoughts on how to best proceed in this matter would be greatly appreciated.

We appreciate your efforts, but I have to be honest — it feels like you're wasting your time. This issue is happening in East San José. If it were in Willow Glen, Naglee Park, in any other affluent area of San Jose or in front of a city director's home or one of their friends' homes, the word "may" would be replaced with "would," and the vehicle WOULD have been removed long ago.

The individual with the van is making a mockery of both the city and the neighborhood. It's frustrating to see residents trying to improve their communities while the city fails to support those efforts. The tools for enforcement exist, but they're being interpreted in ways that benefit those exploiting the system — many of whom don't even live in the neighborhoods they're affecting.

It's clear that tow operators have an undue and overreaching influence on these programs. If there's no financial incentive to the tow operator, the vehicle doesn't get towed. I've seen this pattern repeatedly over the years. The city doesn't tag vehicles unless the tow is profitable for the tow operator, and as a result, they remain on the

street. The tow operators are running the city's program behind the scenes and shaping policy to suit their interests.

I recently had a run-in with one of these unscrupulous operators — someone who also contracts with the city — over an illegal private-party tow. They had to refund the full cost after wrongfully towing my 88-year-old father's vehicle from a Home Depot parking lot.

While reviewing the 2013 audit report titled *"Consulting Agreements: Better Enforcement of Procurement Rules, Monitoring, and Transparency is Needed,"*

Key Findings from Audit Recommendations Related to Towing:

1. Lack of Oversight and Transparency

- Tow contracts lacked consistent monitoring.
- Retroactive approvals of tow service agreements were flagged as problematic, with city staff authorizing work before contracts were finalized.

2. Financial Incentives Driving Enforcement

- Tow operators were found to influence which vehicles were towed, often prioritizing those with financial value.
- Vehicles with little or no resale value were less likely to be removed, raising equity concerns.

3. Operational Inefficiencies

- The city's decentralized management of towing zones and contracts led to inconsistent enforcement.
- Recommendations included streamlining contract administration and improving coordination between departments (Police, Code Enforcement, Transportation).

4. Equity and Neighborhood Disparities

- Enforcement was found to be uneven across neighborhoods, with lower-income areas receiving less consistent service.
- The audit recommended prioritizing equity in enforcement and ensuring all communities receive fair treatment.

5. Improved Service Delivery

- Suggestions included better tracking of complaints, clearer criteria for vehicle abatement, and more proactive outreach to impacted residents.

I noticed that at least six of the nine findings still seem relevant today. It may be time for a new audit — one that revisits policies, procedures, and equity in enforcement.

This change must come from the top. Without clear direction from the City Council, nothing will improve.

Davide;

Thank you for your email and for referencing the information on our Vehicle Abatement webpage.

The language you quoted is accurate, and the qualifier "...it **may** be cited or towed" correctly reflects our enforcement process. In this case, the portion referring to vehicles missing a windshield does not apply, as the subject vehicle is not missing its windshield. Instead, the windshield is shattered, which is treated differently under the law and under our investigation protocols.

A shattered windshield is one of several indicators that may suggest a vehicle is abandoned, which is why we have investigated this vehicle multiple times. Each investigation includes documenting the vehicle's condition with photographs, marking the tires, and placing a warning notice. Each time, the vehicle has moved before meeting the criteria for enforcement, and therefore no citation or tow has been warranted.

As I mentioned previously, I understand that situations like this can be frustrating, particularly when the visual condition of a vehicle impacts a neighborhood. Unfortunately, under the current legal framework, we do not have an enforcement mechanism that would allow us to remove this vehicle.

If it would be helpful, I'm happy to discuss this by phone. A short conversation can often clarify the process and address some of the common misconceptions around parking enforcement and vehicle abatement.

An investigation includes a field visit by Parking Officers, who leave a warning notice to the vehicle owner. If the vehicle is then moved, no enforcement action is needed. If the vehicle is not moved or fixed, it may be cited or towed.

Among the violations listed on the Vehicle Abatement web page above:

Vehicles are considered a safety concern or contributing to extreme blight if they are:

- Missing or have shattered windows

Vehicles are considered inoperable if they are missing:

- The windshield

The vehicle in question manifests the conditions on the city's own Vehicle Abatement page that says it may be cited or towed.

Hello Arian,

How does the following not apply in this case?

26710. (a) It is unlawful to operate any motor vehicle upon a highway when the windshield or rear window is in such a defective condition as to impair the driver's vision either to the front or rear. <https://law.justia.com/codes/california/code-veh/division-12/chapter-4/section-26710/>

If it is unlawful to operate a vehicle in this condition on the highway, how is it lawful to operate this vehicle on a city street? Aside from its obvious blight, when it operates on our city streets, it poses a danger to other vehicles, cyclists, and pedestrians.

Your response tells me that DOT is unserious about removing blighted vehicles from our streets.

Davide,

Director Ristow asked that I review this vehicle, its SJ311 case history, and provide you with a response. I understand your frustration with the vehicle's condition and the length of time it has remained in your neighborhood. Unfortunately, there is no legal mechanism that allows the City to tow a vehicle solely based on appearance or upon request. The California Vehicle Code (CVC) strictly defines the circumstances under which local agencies have the authority to tow a vehicle, and this vehicle has not met any of the required criteria during our investigations.

While we recognize the frustration these situations can cause, our enforcement actions must conform to the legal standards established in the CVC. We will continue to monitor this location as part of our citywide patrols, and if at any point the vehicle meets tow criteria, we will take the appropriate action.
