\$750,000 from \$250,000 for the period October 1, 2024, to June 30, 2026 to assist with cost of development study, feasibility analysis, and review of housing development proposals.

- (ii) Parking Management Program award for the 'Advancing Curb Management Project', in an amount not to exceed \$2,000,000, with a local match of \$259,121.
- (b) Adopt a Federal Transportation Resolution of Local Support for the San José Community Electric Vehicle Charging Access Project, and the Advancing Curb Management Project that demonstrates the City of San José will take the necessary assurances to implement the Metropolitan Transportation Commission grant awards and will follow the Metropolitan Transportation Commission Funding Delivery Policy and the grant program requirements.
- (c) Adopt a Transit Oriented Communities Resolution of Local Support for the Station Access and Circulation Project, and the Parking Management Project that demonstrates the City of San José will take steps toward achieving compliance with the Metropolitan Transportation Commission's Transit-Oriented Communities Policies.

- 4.) Return to council by Fall of 2026 with an analysis of
 - a.) Rebate and financing programs being able to cover the need for homeowners with a household income under 100% of AMI to determine if the exemption should be sunset.
 - b. With an analysis of prewiring requirements for renovations and entire home remodel projects; the analysis should include a recommended threshold for implementation of these prewiring requirements.

Councilmember George Casey addressed his concerns related to the ordinance.
