WHEREAS, the City of San José ("City") City Council desires to adopt this resolution for

the reasons set forth in the memorandum, dated November 24, 2025, from the Director

of Housing or their designee for the December 16, 2025 City Council meeting; and

WHEREAS, the City continues to expand its network of Emergency Interim Housing (EIH)

sites to provide safe, dignified temporary housing for individuals experiencing

homelessness; and

WHEREAS, the City invests in a broad portfolio of programs to support individuals

experiencing homelessness, including various interim housing sites, all aligned with the

City's goal of achieving functional zero for homelessness; and

**WHEREAS**, the City's interim housing portfolio, offers supportive services, operations,

and asset management to help residents transition toward stable housing; and

WHEREAS, on November 14, 2024, as part of the approval of Planned Development

Rezoning PDC22-132 for the Good Samaritan Hospital campus, the City Council

approved a supplemental recommendation from Vice Mayor Foley and Mayor Mahan

requesting that HCA Healthcare contribute \$3,000,000 to support the City's housing and

homelessness initiatives; and

WHEREAS, HCA Healthcare/Good Samaritan has paid the full \$3,000,000 contribution

to the City; and

WHEREAS, as described in the memorandum dated November 24, 2025 from the

Housing Director and Budget Director, staff recommends allocating \$2,000,000 of this

contribution to support operations at the Cherry EIH site in Fiscal Year 2025-2026, and

\$1,000,000 to support future affordable housing development activities; and

WHEREAS, HCA Healthcare/Good Samaritan's contribution will allow the City to replace

a portion of previously allocated Measure E funds, realign resources across the interim

housing system, and strengthen long-term affordable housing efforts;

**WHEREAS**, to efficiently receive, allocate, and utilize these funds, the City Manager,

Director of Housing, or their designees, must be authorized to negotiate and execute all

documents and agreements necessary to administer the contribution, including

amendments and related funding documents, without requiring further City Council

approval; and

WHEREAS, approval of this action will enhance the City's homelessness response

system and support the development and sustainability of critical housing resources for

vulnerable residents;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SAN

JOSE THAT:

The City Manager, or their designee, is hereby authorized to accept the contribution of

\$3,000,000 from HCA Healthcare/Good Samaritan to fund operations for the Cherry

Emergency Interim Housing site and affordable housing projects, and to negotiate and

execute related documents to receive grant funds without requiring further City Council

action.
