WHEREAS, the Silicon Valley Youth Climate Action ("SVYCA") will host the San José Youth Climate Video Contest Screening and Awards Event, in collaboration with the City's Energy Department, at the Wing Committee Rooms and Council Chambers on Saturday, January 24, 2026; and

WHEREAS, SVYCA is a 501(c)(3) nonprofit that empowers teens and young adults to address the climate crisis through hands-on education, leadership development, and policy engagement; and

WHEREAS, the San José Youth Climate Video Contest Screening and Awards Event is a free public program recognizing middle and high school students who created short films addressing climate change solutions aligned with Climate Smart San José; and
