SUBJECT: Seventh Amendment to the Agreement with Kone, Inc. for Elevator Maintenance Services

RECOMMENDATION

Adopt a resolution authorizing the City Manager, or her designee, to negotiate and execute the Seventh Amendment to the Agreement with Kone, Inc. (Moline, Illinois) for elevator maintenance services to:

- (a) Extend the term of the Agreement for up to two additional one-year option terms for a total of 19 options through November 20, 2027, subject to the appropriation of funds;
- (b) Amend the scope of services to include approximately 34 elevators not previously covered under the Agreement; and
- (c) Increase the total compensation by \$1,591,220 for a maximum compensation not-to-exceed \$5,341,192 to cover the estimated cost for the option term beginning on or about November 21, 2025 and ending on or about November 20, 2026, subject to the appropriation of funds.

BASIS FOR RECOMMENDATION

The Public Works Department, in coordination with the Transportation Department, oversees the maintenance and repair of elevators at various City Hall facilities. The elevators require regular maintenance, testing, and inspection services to ensure proper and safe operation for City employees and the public, and compliance with state law.

In May 2007,¹ City Council authorized staff to enter into an agreement with Kone, Inc. to provide elevator maintenance services to the City. Between June 2009 and May 2023,² the agreement was amended multiple times to extend the term, revise the scope, and adjust the compensation to meet the City's changing needs. The current term of the agreement expires on November 20, 2025. Staff are currently working on a new solicitation for comprehensive Citywide elevator maintenance services. Staff expect that solicitation will be released by January 2026. Given the complexity and comprehensiveness of the solicitation however, staff does not expect that the solicitation and award of contract or contracts will be completed before January 2027. In the meantime, it is important to service and repair the elevators as needed without any interruption to meet safety and compliance requirements.
