**SUBJECT: APPROVAL OF DISTRICT 1 SAN JOSE SHARKS COMMUNITY FUNDS
FOR AMERICAN LEADERSHIP FORUM SILICON VALLEY**

RECOMMENDATION

1. Approve a \$1,000 grant to American Leadership Forum Silicon Valley to support its leadership development programs.
2. Place the item on the April 7, 2026, Council Agenda for action.

BACKGROUND

Pursuant to [City Council Expenditure and Reimbursement Policy, Policy Number 0-38](#), Section K "Grants," Item 6 "Any contribution to an organization proposed by the Mayor or a Councilmember who is a member of, or receiving services from, that organization must be approved in advance by the City Council." I am a Senior Fellow of the American Leadership Forum Silicon Valley (ALF).

Approval is requested to expend \$1000 from the budgeted District 1 San Jose Sharks Community Fund allocation to support ALF for its continuous work and leadership programs. ALF funds are used to support leadership programs, leadership development experiences, and convenings that foster collaboration among participants.

ALF advances its mission by convening and developing diverse, cross-sector leaders through its selective, year-long Fellows Program and ongoing alumni engagement. Participants engage in facilitated dialogue, explore differing perspectives, and build the relationships and leadership capacity needed to address complex community issues. Through these structured experiences, ALF fosters collaboration and trust among leaders

and supports broader regional impact, including providing leadership insight and facilitation to public sector partners like the City of San José and Santa Clara County.
